Fees are to be paid by standing order / bank transfer or childcare voucher [for part payments] and to be **cleared in our account by the 1st of the month.** There will be a £50.00 late payment fee for payments received after the 1st. **Monthly fees MUST BE PAID by the 1st of the month in advance.** If accounts are outstanding by more than 10 days from the 1st of the month, the nursery reserves the right to terminate your child's place with immediate effect.

Fees are calculated based on the nursery being open 51 weeks a year and divided into 12 equal monthly payments.

We ask that children attend a minimum of 2 full days. We do not offer half days as a permanent booking, only as an ad hoc booking once your child is already attending nursery and subject to availability.

Upon registration a non-refundable fee of £50.00 is payable and upon start date confirmation a deposit of £250.00 will need to be paid. The deposit will be deducted from the final fee payment providing that **one calendar month notice [NOT PART THROUGH OR 4 WEEKS] has been given in writing/email to the nursery.**

We reserve the right to apply a late collection charge of £15.00 for any time up to 10 minutes after your child's session has ended and then an additional fee of £1.00 per minute for every minute after that.

Private Fees include for all ages:

Breakfast, morning snack, cooked lunch, afternoon snack and a light tea. Cow's milk and Soya Milk [at snack times] and water throughout the day. Parents are to provide formula milk, nappies and wipes.

Government Funding:

Early years universal [15hrs] funding which is for 38 weeks per year is available for some 2-year-olds [subject to eligibility criteria] and all children from the term after their third birthday. Stretched Funding Entitlement

Children from the term after they have turned 9 months to 4-year-olds may be eligible for 30 hours a week funding for 38 weeks. We stretch the 30 hours over 51 weeks, meaning eligible children can receive up to 22 funded hours per week for 51 weeks.

Eligible children who receive the 15 weekly hours for 38 weeks, we stretch these over 51 weeks, meaning eligible children receive 11 funded hours per week for 51 weeks.

15 hours [Universal] Funded Only Places:

If you would like your child to come to the Nursery **for funded hours only**, then we request a deposit of £150 which will be refunded 8 weeks after your child has started. The sessions we offer [subject to availability] for these are:

- 10.30am to 4pm - 2 days a week

There is an optional service charge of £10.00 per session - If you choose to opt-out you will be asked to supply snacks, lunch and milk. Please ask for our full list of items/food for you to provide.

30 hours [Universal plus Extended] Funded Only Places:

If you would like your child to come to the Nursery **for funded hours only**, then we request a deposit of £150 which will be refunded 8 weeks after your child has started. The sessions we offer [subject to availability] for these are:

- 10.30am to 6pm - 3 days a week

There is an optional service charge of £10.00 per session - If you choose to opt-out you will be asked to supply snacks, lunch, milk and tea. Please ask for our full list of items/food for you to provide.
